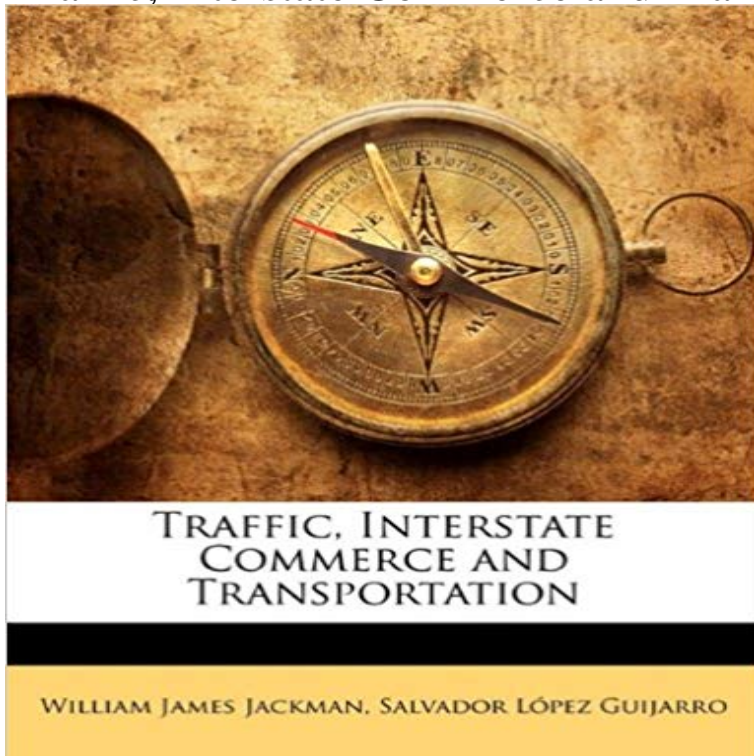


Traffic, Interstate Commerce and Transportation
